# **TELEPHONE INFORMATION SERVICE (TIS)**

We are known for our unique Telephone Information Service (TIS), a free and confidential service that assists over 16.000 Victorian, Oueensland and Tasmanian workers every year with their rights at work.

Through the TIS, we provide legal information and referrals relevant to the individual situations of the callers. Our consultants always provide a range of legal options and referrals to other services that may be able to provide additional support.

#### **LEGAL PRACTICE**

We run a legal casework practice supporting over 500 vulnerable Victorian workers every year with their rights at work. The majority of our clients are not union members, cannot afford a private lawyer, and cannot selfrepresent on their matter.

We run special projects that address specific workplace issues, including a legal clinic for international students, legal representation for women experiencing family and domestic violence, and legal representation for dismissed workers.

#### **COMMUNITY LEGAL EDUCATION**

We deliver legal education and information for all workers and other sector partners. Knowledge about workplace rights provides workers with the tools they need to address exploitative work practices.

We provide speakers and run workshops on employment rights. These can be tailored for different audiences including schools, universities, training programs and community groups. We also assist other organisations with advice, educational material and training.

#### LAW REFORM WORK

We take a leading role in government advocacy, media campaigns and law reform activity to promote workplace justice and equity for all workers. We make submissions to a range of government inquiries, using our extensive database and our understanding of the human impact of government policy decisions.
